2. Understands that employee is responsible for his/her own telephone, postage, personal travel and other personal expenses, including AGRI PLACEMENTS INTERNATIONAL fees for placement and off job insurance.
3. Agrees to provide time and help arranging transportation for employee to and from airport/bus terminal.
4. Agrees that AGRI PLACEMENTS INTERNATIONAL will use reasonable efforts to facilitate and mediate any disagreement, misunderstanding or serious problems between employer and employee. Employer agrees to notify AGRI PLACEMENTS INTERNATIONAL when issues arise.
